# Independent Support Information Pack

---

## **Why you need this pack and what's in it?**

This pack contains useful information if you have a child or young person aged 0-25 years, with Special Educational Needs (SEN). It contains information about recent changes; what you can expect and how you can get support.

## **What is changing?**

The Children and Families Act 2014, which came into force on the 1<sup>st</sup> September 2014, changed the way in which children and young people with SEN receive support.

## **Did you know..?**

The government has funded a new impartial **Independent Support** service to support you through the changes.

# Key Changes

---

## **Statements, Learning Difficulty Assessments (LDAs) and Education Health & Care Plans (EHCPs).**

- As you may know **Statements of Special Educational Needs/LDAs** will change to **Education, Health and Care Plans (EHCPs)**. An EHCP brings together a child or young person's education, health and social care needs into a single, legal document.
- **Putting Families First** - your local authority must listen to you and your child/young person's views, wishes and feelings and ensure that you are involved as fully as possible in decisions that affect your child/young person's support.

The Children & Families Act gives new rights directly to young people once they reach the end of the school year in which they turn 16 (usually year 11). At that point, they can ask for the help of an Independent Supporter in their own right, whether or not they wish their parent/carer to help them.

# What is new?

---

## ● **0 to 25**

The SEN system has been extended from birth to 25, which may mean your child/young person can be supported for a longer time.

## ● **Local Offer**

Every local authority has published a detailed directory of local education, health and social care services that are available for children and young people with SEN – called the Local Offer. The Local Offer provides clear and accurate information about these services and should make it easier to choose and access the services your family needs.

## **Personal Budgets**

- You have a right to request a personal budget for your child/young person's support. A personal budget is an amount of money your local authority has identified to meet some of the needs in the EHCP. You/your young person can be involved in deciding how this money is spent. Your local authority should have a policy about which education, health and social care services are available using a personal budget.

# How can our Independent Supporters help you?

---

Our Independent Supporters can help you at any point throughout the process of transferring your child/young person's statement to an EHC plan.

## **This may include support to:**

- Ensure your views and your child/young person's views, wishes and feelings are central to the process
- Help you complete paperwork, including your contribution or your child/young person's contribution to the EHCP
- Understand the process and timelines
- Attend and participate in meetings
- Help you understand professional reports and their recommendations and feed back on the draft plan
- Understand the Local Offer and personal budgets
- Understand your local authority procedures
- Find out about other local Information Advice and Support Services.

# New EHC process

- The process for transferring a statement to an EHCP should be completed within 18 weeks (+2 weeks notice). This process is called the "Transfer Review"
- Your local authority should provide you with information about the transfer review process before it starts
